- (18) page 5, figure 1: in relation to the comment that the text in yellow makes reading difficult, the figure was edited, changing the colors of the lithologies and the font of the texts;

 - (20) page 5, line 11: added reference "Miall 1978";
 - (21) page 6, line 13: change the spelling "table" to "Table";
- (22) page 10: in relation to the comment: "Is the sandy/heterolithic interval next to the "block" allochthonous? Is the bedding in this interval consistent with the rest of the section?", the text was adapted on the page 11, line 26: "Several levels of sandstone and heterolithic facies S(d) and H(d) with intense deformation and up to 9 meters thick", to justify that the sandstone and heterolithic layers are also deformed, interpreted as allochthonous, as informed on page 12, line 3 "Facies S(d) and H(d), present in this association, would be

allochthonous blocks incorporated and transported in the same flow originating these diamictites";

- (23) page 12, line 15: change of the sentence "mass transport deposits (MTDs)" to "MTDs";
 - (24) page 14, line 5: added parentheses to the reference year;
- (25) page 15, line 33: change of the sentence "Mass transport deposits (MTDs)" to "MTDs";
 - (26) page 18, line 23: change the spelling "Cenpaleo" to "Cenpáleo";
 - (27) page 21, line 28: added the comma after the year of the reference;
 - (28) page 24, line 4: change the spelling "formation" to "Formation";
 - (29) page 25, line 28: change the spelling "formation" to "Formation".
